

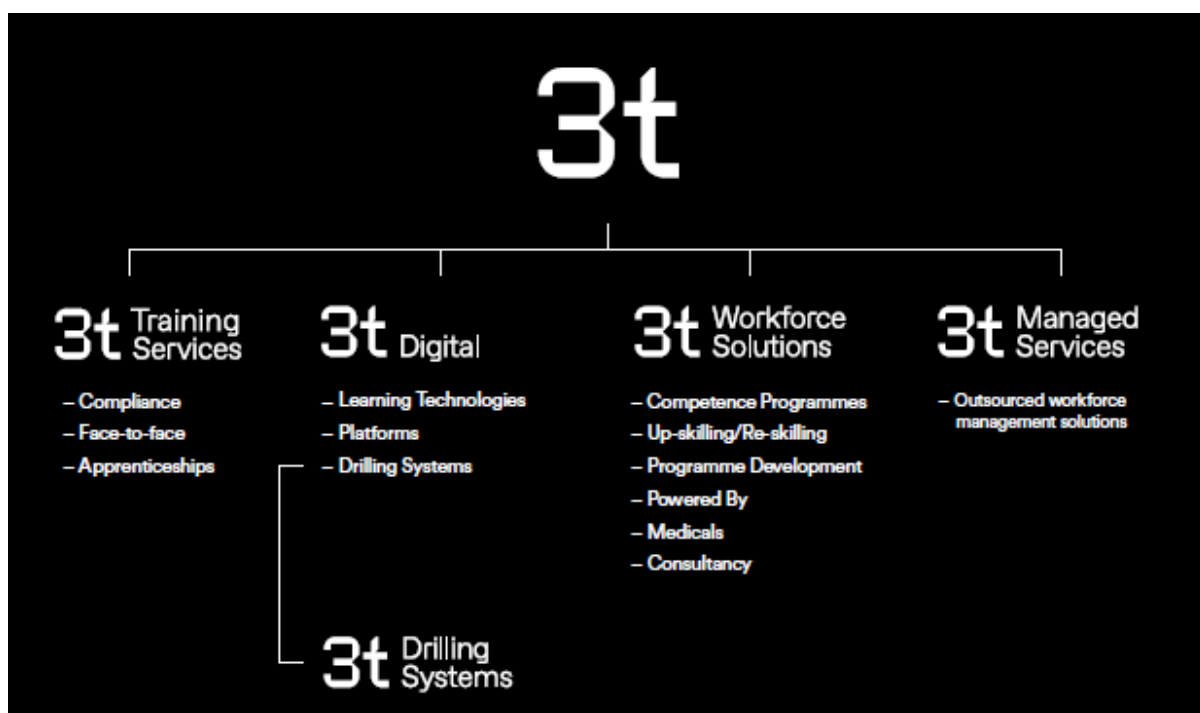

Survivex Limited and Survivex TMS Limited
